Efficiency Nova Scotia has partnered with a number of distributors to bring you premium energy efficient products at the same cost or less than inefficient types. Instant rebates are available on a number of products directly at participating electrical distributors.

Mail-in rebates are also available on additional energy efficient products. Simply select and install products from our approved list and complete the following form to receive your rebate.

Please note: Mail-in rebates are not available on products where instant rebates are available at participating electrical distributors.

TERMS & CONDITIONS

REBATE OFFER is for new equipment purchased and installed in 2012 and is subject to change without notice and may not be combined with any other Efficiency NS Corporation offer. ELIGIBILITY Program funding is limited and will be allocated by Efficiency Nova Scotia Corporation in a manner that best serves the interests of the Program. Equipment Installation must meet the following requirements to be eligible for rebates: (1) Equipment must be installed in a non-residential building serviced by a Nova Scotia electric utility. (2) Equipment installed must reduce electrical consumption. Efficiency Nova Scotia may in its sole discretion approve or reject any requested rebate at any time.

EXCLUSIONS Cogeneration, self-generation, demand-limiting, power factor correction and fuel switching are not eligible for rebates.

PRE-APPROVAL is required prior to purchase for rebate forms including greater than 100 items or a total rebate amount greater than \$2,000.

REBATE PAYMENTS The Applicant must submit the documents described below in order to be eligible for rebate payments. Required documents include: (1) Application Form (2) Appropriate Worksheets (3) Proof of Purchase (4) Manufacturer Specification Sheets, (5) A copy the Applicant's electric bill showing the Nova Scotia Rate Code or other information deemed necessary by Efficiency Nova Scotia Corporation to adequately review the rebate request.

PROOF OF PURCHASE includes invoice(s) indicating the size, type, manufacturer, model or part number, purchase date, and vendor of the efficient equipment. Efficiency Nova Scotia Corporation reserves the right to verify sales transactions.

POST-INSTALLATION VERIFICATION: The Applicant must provide Efficiency Nova Scotia Corporation with reasonable access to the Installation Address to inspect the equipment installation. Efficiency Nova Scotia Corporation reserves the right to withhold, revise or reclaim any rebate until it has performed a satisfactory post-installation verification. CONSENT The Business Energy Rebates Program may require the sharing and exchange of information between Efficiency Nova Scotia Corporation and third parties such as the Applicant's electricity provider. By participating in this Program, the Applicant hereby irrevocably consents to the release, use, storage and exchange of information between Efficiency Nova Scotia Corporation and necessary third parties, including, but not limited to, name(s), addresses, electricity usage history, and phone number, for the purposes of implementing and

ENDORSEMENT Efficiency Nova Scotia Corporation does not endorse any particular manufacturers, products, or system designs in promoting this program.

PAYMENT Allow 60 days for delivery of payment. Submitting a rebate form with incomplete or missing information will delay processing of payment.

MAXIMUM PAYMENT will not exceed 100% of the equipment purchase price. Program participant/contractor is responsible for all costs associated with sales tax, installation, and disposal/recycling. Customer is responsible for any tax liability of rebate payment.

CAPACITYCREDITS/ENVIRONMENTAL CREDITS In accepting these financial incentives, the customer agrees that Efficiency Nova Scotia Corporation holds the sole rights to any

electric system capacity credits and/or environmental credits associated with the energy efficiency measures for which incentives have been received. These credits will be used for the benefit of Efficiency Nova Scotia Corporation ratepayers.

AGREEMENT The Customer agrees, as a condition of participation in the Program, to remove, disable and dispose of the equipment being replaced by the Measures in accordance with all laws, rules, and regulations. The Customer agrees not to reinstall any of this equipment anywhere in the Province of Nova Scotia, or transfer it to any other party for installation in the Province of Nova Scotia.
